approved balls must be used for each match. The cost of the balls shall be borne by the Home Team (Rule 21.4).

5. Results must be input no later than **5pm on the day after the fixture.** Results of Play-Off matches must be input no later than **12 noon on the day after the fixture.**
6. The responsibility of inputting results rests with the winning team.
